The quarter pertains to the calendar year, following the same cadence the reporting periods follows. The date of release should be reported as the deadline for form submission, 10 days after the end of each reporting period. A new separate form must be posted covering each quarterly reporting period (September 30, December 31, March 31, June 30), concluding after either (1) posting the quarterly report ending September 30, 2023 or (2) when an institution has expended and liquidated all (a)(1) Institutional Portion, (a)(2), and (a)(3) funds and checks the “final report” box. ADDENDUM A

CAMPUSCARE BENEFITS FOR EDP STUDENTS AND THEIR FAMILIES (PARENTS AND SIBLINGS OR SPOUSES AND DEPENDENTS):

- Teladoc: 24/7/365 General Medical by phone or online video
- Health Advocate: 24/7/365 Counseling by phone
- NBRx: discount on prescriptions (from participating major retail providers such as Walgreens and CVS)
- Coast to Coast Vision: discount on eye exams, glasses, contacts, etc. from participating retail providers

COST: \$10 per month per student for CampusCare.

PAYMENT DUE DATE: Billing date to EDP from CampusCare is the last day of each month. Payment is due from EDP to CampusCare within 15 days of billing date.

EDP STAFF: CampusCare will offer CampusCare benefits to EDP staff and their families at **no charge** commencing on the first date of each semester and ending the last day of the semester. CampusCare services to staff and their families are contingent on 100% participation of all enrolled EDP students.

REVENUE SHARE FROM CAMPUSCARE TO EDP: CampusCare will share revenue with EDP (\$3 per student per month) to be used for student scholarships; student academic enrichment services or student support services. CampusCare will share revenue based on semester enrollment of EDP students. CampusCare will pay the cumulative revenue semester share to EDP within 15 days of the end date of each semester and after all payments from EDP to CampusCare are received for the semester.
